## **Identified SDGs issues by UNDP Accelerator Lab**

- Digitization a priority for the Government of Nepal (GoN)
  - Federal, provincial and local government
  - 2019 Digital Nepal Framework adopted by federal government
  - More than 36 million internet users with 74.63% using mobile internet
  - Facebook, viber and whatsapp most famous messaging apps

#### • During COVID-19 Acclab Nepal worked with GoN on:

- Returnees tracking system
- Job matching portal for returnees during COVID-19
- Digitalization of vaccine record in 7 municipalities
- Developed e-commerce platform "krishicoopbazar" for farmers cooperatives
- Business continuity (ZOOM license) provided to all 753 local government, provinces and at federal level
- Websites and online services for e-governance increasing





## Identified SDGs issues by UNDP Accelerator Lab

Online query handling system for government services is very limited

- Navigation to e-governance is difficult for a large segment of public
- Limited query addressing time (office-hour)
- Loss of time and investment in addressing queries manually
- Insufficient service delivery for strong e-governance
- Public dissatisfaction with government e-services

#### Possible area of conversational AI trial in

- Lalitpur Kirtipur and Panchkhal Municipality
- National Information Commission
- Commission for the Investigation of Abuse of Authority (CIAA)
